# TAXES - TAXES - TAXES - AGAIN

We all received notices dated June 30 from the McLean County Board of Review with another 1.0638 Township Multiplier. If you don't appeal within 30 days, this will result in another substantial increase in your tax bill in September - an accumulated increase of 17% in the last three multipliers. Last July, 30 homeowners filed appeals to the State on the 1.0769 multiplier of which 23 had the multiplier removed and the rest received partial decreases. In December, 50 homeowners filed appeals to the County, with most homeowners receiving some relief and 10 pending appeals on to the State. Current market conditions do not justify these increases in our assessments. Call Annette Hancock at 728-2990 to be included in the neighborhood appeal to the State.
