RECIPE ROUNDUP

PUPPY CHOW

1/4 lb. Butter

1 c. Peanut Butter

1 lb. Powdered Sugar

1 lg. Box Crispix Cereal

12 oz. Milk Chocolate Chips

Melt butter, peanut butte and chocolate chips in a microwave on medium setting 2 minutes or longer until melted. Stir to blend. Place one large box of Crispix cereal in a large pan and pour chocolate mixture over top. Stir to coat. Place powdered sugar in a groćery bag. 
