Burn Ban

Effective immediately, the Towanda Fire (TFD) has decreed a territory-wide burn ban. This decision has been made in response to increased fire risks caused by the current dry weather conditions. The burn ban will remain in effect until further notice and applies to all open fires, including campfires, bonfires and trash, yard debris or brush burning.

Alternative methods for disposing of debris, such as chipping or composting, are encouraged. Additionally, Towanda Fire Department urges residents to exercise caution while using outdoor grills or cooking equipment with open flames. Properly maintaining and monitoring such equipment, and keeping a fire extinguisher nearby, can significantly reduce the risk of accidental fires.

The Towanda Fire Department will continue to monitor weather conditions and assess fire risks throughout the territory. The public will be notified once the burn ban is lifted.

Residents' and visitors' cooperation and understanding in supporting these precautionary measures to safeguard the Towanda Fire Department District community are important and much appreciated.

Water Hydrant Flushing Schedule – 2023

The six water hydrants located in Indian Creek subdivision will be flushed on the dates listed below. Water hydrants are flushed in order to reduce the build-up of sediments in our water system. This is an important process for improving water quality. Our water operator will flush one hydrant at a time and allow it to run for 10-15 minutes (the next in line hydrant is opened concurrently for a brief period to keep water flowing through the system). Water pressure in our system's lines is maintained by the 35,000 gallons of water in our tower, however, pressure in home lines will be reduced during flushing much like when multiple faucets are opened in your homes. Flushing the hydrants will also stir up sediments so please follow the procedures listed below:

- Do not run water during the flushing time period.
- Following flushing, run water through faucets until clear. We recommend this be done by-passing any treatment/filtering system in your home because of the increased sediment stirred up during the flushing process.

Please mark your calendars with the dates listed below. Flushing will be done between 5:30 a.m. and 6:30 a.m. weather permitting. Hydrants will not be flushed in freezing conditions or other inclement weather.

Monday, August 28	Monday, November 27
Monday, September 25	Monday, December 18

Water System Projects



Our chemical treatment building has been installed and is operating. Chlorine treatment previously done inside the water tower base is now being processed in the new building. This will eliminate the corrosive impact of the chlorination process on the water tower base interior. Moving this process out of the water tower was also required prior to beginning the water tower refurbishing project.

A special thanks to Andy and Joe Kaufmann (Catalyst Construction) and Brett Lueschen for all the great work they did to get our chemical building built and operational! We will benefit from this for many years to come!

The water tower refurbishing project is scheduled to begin in early July. Further information about the project schedule will be provided to residents by email. A banner describing the project funding source will be placed near the tower during construction. This signage is a requirement in order to obtain the EPA loan and the wording is specified by statute.

Summer Lawn Watering

Please follow our recommended summer watering schedule by only watering on even or odd days corresponding to your street address number and limit watering to 3-4 hours. This will help ensure our well pump can replace water being used in our tower. Summer water usage typically is much higher than the rest of the year and can strain our water system capabilities.

We will be issuing more stringent summer watering instructions when the water tower refurbishing is underway because we will be reliant upon a pressurized tank with much less capacity than our water tower during this period.
